III. Club or venue agrees to provide, free of charge, unlimited water, coffee, tea, and soft drinks to members and crew of The Six Million Dollar Band for the period(s) of contacted performance, to include load in, set up, sound check, breakdown, and load out times.

IV. The Six Million Dollar Band agrees to furnish all equipment necessary to facilitate each performance (i.e., Musical instruments, sound equipment, etc.) unless a professional grade sound system is permanently installed at venue. Club or Venue agrees to provide a proper, safe, easily accessible, sufficiently powered, area (stage or platform) for each performance. Club or venue will provide sufficient security so that no unauthorized persons will have access to the stage area. Club or venue shall be responsible for any theft or damage to the equipment that may occur during the time the equipment is located on the club or venue's premises.



V. Club or venue agrees to retain any and all necessary personal injury or property damage liability insurance with respect to the activities of The Six Million Dollar Band while on the premises. Club or venue agrees to indemnify and hold The Six Million Dollar Band harmless from any and all claims, liabilities, damages and expenses arising from any actions while rendering the contracted services, except for claims arising from willful misconduct or gross negligence.

VI. No performance by The Six Million Dollar Band may be recorded, transcribed, or recreated by any means whatsoever without the express written permission of Band Representative.

VII. This agreement may be revoked only by written notice from either Signing Party no less than 15 (fifteen) days prior to scheduled performance, or by reason of inclement weather, or bona fide emergency. In the event of detention by sickness, accident, riot, strikes, epidemic, acts of God, or other legitimate conditions beyond the control of The Six Million Dollar Band, both Parties agree to negotiate another performance date acceptable to all.
